I/We furthermore agree to save harmless and indemnify The Firing Line Gun Club (1986) Inc., its board of directors, Officers, members and guests, and all other persons, against all loss, claims, damages, expenses which may be made against them or any of them by reason of any damage, loss, injury or death, whether resulting from my or their negligence or otherwise, arising directly or indirectly from any activity or event.

I/We understand that non-compliance with the safety regulations may be just cause to terminate my membership without recourse or refund of any membership monies paid. I/We will be held exclusively responsible for properly registered firearms in my possession, and all appropriate documentation and permits allowing me to participate at the Gun Club.

I/We understand that two persons must be present to shoot, and that I will participate in an orientation program on range safety prior to using the facility and adhere to the club and range rules. In the event that I am permitted to shoot alone I agree to hold the FLGC harmless.

I/We understand that, to be a member of The Firing Line Gun Club (1986) Inc., I/we must also be a member(s) of the Manitoba Provincial Handgun Association (MPHA).

I/We understand that the range can be used for all handgun calibers and for .22 rim fire caliber rifles and rifles chambered in a pistol caliber only.
